Respective responsibilities of the Trustees and Independent Examiner

Notes to the Financial Statements

- The Financial Statements of the PCC have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts & Payments basis.
- 2. There were no non-monetary assets, liabilities or provisions for donations at 31 December 2022 and 31 December 2021.
- 3. There is no record of the historical cost of any other non-monetary assets.
- 4. Subsequent to the year-end date an amount of £33,780 was paid for the restoration of the Samuel Green Organ and £5,630 was received from the Listed Places of Worship Grant Scheme in respect of VAT paid on the above. This reduced the balance on the organ fund to £206.
